On July 27, 2021, Governor Steve Sisolak issued [Emergency Directive 047](#), which mandates the wearing of masks in a manner consistent with current guidance from the Centers for Disease Control and Prevention, which is currently that masks be worn in all indoor settings, regardless of vaccination status.

"With Labor Day weekend before us, each licensee must continue to comply with Emergency Directive 047, which mandates masks for both vaccinated and unvaccinated employees, guests, and patrons, subject to the directive's limited exceptions." said Chair J. Brin Gibson. "The Nevada Gaming Control Board will continue to enforce this directive with the goal of decreasing COVID-19 positivity rates in this State."

The Board reminds its licensees, gaming employees, and the general public that a licensee in violation of any federal, state, or local law or regulation is a violation of Nevada Gaming Commission Regulation 5.011, and that the Board may seek disciplinary action by the Nevada Gaming Commission for any such violation.

The Nevada Gaming Control Board governs Nevada's gaming industry through strict regulation of all persons, locations, practices, associations and related activities. The Board protects the integrity and stability of the industry through its investigative and licensing practices, and enforces laws and regulations, while holding gaming licensees to high standards.
